CIWM (WAMITAB) Level 2 Award for Parking Enforcement Officers

About this qualification

Develop the knowledge and skills needed to work as a parking enforcement officer in the private or public parking industry throughout the UK.

This qualification focuses on developing conflict management skills in those individuals employed as civil enforcement officers, parking attendants, parking enforcement officers and CCTV enforcement officers.

Who is it for?

- New entrants to the parking industry
- Experienced workers seeking a formal qualification

How is this qualification delivered?

This qualification can be delivered face to face or virtually in a classroom environment and assessed by multiple choice question paper.

What does this qualification cover?

To achieve this qualification, learners must complete the mandatory unit which focuses on managing conflict in the enforcement of parking control and management.

Learners must then choose from six optional pathways to achieve an additional unit:

- **Optional pathway 1:** Roles and responsibilities of civil enforcement officers operating under traffic management legislation (England and Wales).
- **Optional pathway 2:** Roles and responsibilities of parking attendants operating under road traffic regulation act 1984 legislation (England and Wales).
- **Optional Pathway 3:** Roles and responsibilities of parking enforcement officers carrying out parking control and enforcement on private land (England and Wales).
- **Optional Pathway 4:** Roles and responsibilities of parking attendants operating under road traffic act 1991 legislation (Scotland only).

- **Optional Pathway 5:** Roles and responsibilities of CCTV parking and traffic enforcement officers operating under traffic management legislation.
- **Optional Pathway 6:** Roles and responsibilities of parking enforcement officers carrying out parking control and enforcement on private land (Scotland only).

What are the entry requirements of this qualification?

This qualification is open entry. This means that learners interested in undertaking the CIWM (WAMITAB) Level 2 Award for Parking Enforcement Officers do not require any other qualifications or levels of attainment to take this qualification.

What job role could this qualification lead to or support?

This qualification could have significant benefits for the parking workforce as it will act as a gateway for opportunities for career progression or further education by building the confidence of employees and demonstrating that their skills have value. This qualification is ideal for those employed in the following job roles:

- Civil Enforcement Officers
- Parking Attendants
