Additional Guidance (Asbestos Storage in England and Wales)

Household, commercial and industrial waste sites authorised to treat non-hazardous waste but only permitted to store asbestos waste (i.e. SR2022No4 in England and SR2008No7 in Wales) will need MROC1 and HROC4a (15 units) or HROC6 (12 units) to meet the Technically Competent Manager (TCM) requirement for the site. If a TCM on these sites already holds HROC4a, they would only require three additional units to be covered for non-hazardous treatment (OCS12, OCS20 and OCS28).
